3. PROCESSING OF YOUR PERSONAL DATA WITH REGARDS TO GENERAL DATA PROTECTION REGULATION ("GDPR")

Your Rights and Choices Under GDPR

Gameness undertakes to respect confidentiality of your personal data and to guarantee you can exercise your rights. In this regard, you have the following rights regarding our use and disclosure of your personal data, under this Privacy Notice and by law *if you are within the European Union*:

- **Right of Access:** You have the right to obtain confirmation from us as to whether or not personal data concerning you are processed, and, where that is the case, you have the right to request and get access to such personal data.
- **Right to Rectification:** You have the right to request rectification by us of inaccurate personal data and to provide additional personal data to complete any incomplete personal data.
- **Right to Erasure ("Right to be Forgotten"):** In certain cases, you have the right to request from us erasure of your personal data.
- **Right to Restriction of Processing:** You have the right to request from us restriction of process, for a certain period and/or for certain situations.
- **Right to Data Portability:** You have the right to receive your personal data from us in a structured format and you have the right to (let) transmit such personal data to another Data Controller.



- **Right to Object:** In certain cases, you have the right to object processing of your personal data, including with regards to profiling.
- **Right to Not Be Subject to Automated Individual Decision-Making:** You have the right to not be subject to a decision based solely on automated processing.
- **Right to Filing Complaint:** You have the right to file complaints with the relevant data protection authority on our processing of your personal data.
- **Right to Compensation of Damages:** In case we breach applicable legislation on processing of your personal data, you have the right to claim damages from us for any damages such breach may cause to you.

Exercising Your Data Protection Rights arising from the GDPR

You may exercise your rights of access, rectification, erasure, restriction of processing, data portability, object and not to be subject to automated individual decision-making by simply contacting us through the channels provided in this Privacy Notice.

You have the right to complain to a data protection authority about the processing of your personal data. For more information, if you are in the European Economic Area (the “EEA”), please contact your local data protection authority in the EEA.

4. PROCESSING OF YOUR PERSONAL DATA WITH REGARDS TO CALIFORNIA CONSUMER PRIVACY ACT (“CCPA”)

Your Rights and Choices Under the CCPA

Under this Privacy Notice, and by law, *if you are a resident of California*, you have the following rights:

- **The Right to Access/Request:** The CCPA permits you to request and obtain from the Company information regarding disclosure of your personal data that has been collected in the past 12 months by the Company or its subsidiaries to a third-party for the third party's direct marketing purposes.
- **The Right to Say No to the Sale of Personal Data:** You have the right to ask the Company not sell your personal data to third parties.
We do not sell personal information. However, our partners may use technology that "Sells" personal information as defined by the CCPA.

 - o Providing a different level or quality of goods or services to you
